

# Stookey Township Athletic Park Field Reservation (309 Eiler Rd. Belleville, IL 62223)

## Athletic Field User Rules and Regulations - Please read carefully!

Fields may be reserved Monday through Sunday 8 am-9 pm. Requests must be received at least 5 days in advance. Reservations for weekends and holidays must be made no later than Thursday at 4 pm of the prior week.

## Field Rental Fees

All field rentals require a 1-hour minimum rental time for \$15 per hour.

Field preparation (dragging, lining, base set-up) is not included in the reservation fee, but may be provided upon request, depending on staff availability. The field preparation fee is \$30 per field on weekdays and \$50 per field on weekends and holidays.

Tournament rentals will be negotiated on a case-by-case basis.

- Fields 1-7: \$15 per 1 hour
- Fields 8A & 8B (Soccer): \$15 per 1 hour

Renter's willful misrepresentation of any fact contained in the application shall constitute grounds for Stookey Township to, without prior notice or inquiry of any kind, cancel, revoke, or rescind any permit that may have been approved and granted to the Renter.

Cancellations must be provided to Stookey Township in writing at least 14 days in advance to be considered for a full refund. Within 14 days partial refunds may be considered, but are not guaranteed.

The Renter has read and understands the Stookey Township General Use Ordinance/Rules and Regulations and as the responsible party for the field rental, the Renter agrees he/she/they will make all users and participants aware and will actively enforce the rules and regulations associated with the use of the athletic fields.

It is fully understood and agreed that the representative and their organization guarantees to defend, indemnify and hold harmless Stookey Township, its officers, employees, volunteers and agents against any and all liabilities, claims, damages, losses, costs and expenses (including reasonable attorneys' fees) arising indirectly or directly in connection with or under, or as a result of this agreement. It is also understood that the organization will provide and maintain, at its own cost, insurance coverage as outlined in the Stookey Township General Use Ordinance.
