

ORDINANCE 2024-09

AN ORDINANCE APPROVING THE 2024 ANNUAL TAX LEVY AND CERTIFICATE OF TAXES LEVIED FOR STOOKEY TOWNSHIP

An ordinance levying taxes for all town purposes for Stookey Township, St. Clair County, Illinois, for the tax year 2024 collectable in 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP BOARD OF STOOKEY TOWNSHIP, ST. CLAIR COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. That the sum of FIVE HUNDRED SEVENTY-NINE THOUSAND AND NINE HUNDRED SIXTY-FOUR DOLLARS and FOUR CENTS (\$579,964.04) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purpose as:

General Assistance Fund

Police Protection Fund

Social Security Fund

Park Maintenance Fund

IMRF Fund

Town Audit Fund

Tort Judgements, General & Liability Fund

For the year 2024.

Section 2. The Township Board does hereby certify that the amounts levied herein are necessary to be raised by taxation for the Township purposes as specified in each fund.

Section 3. The Township Clerk shall file with the County Clerk of the County of St. Clair, State of Illinois, a certified copy of this Ordinance, and said County Clerk shall extend the rate per centum as provided by law.

Section 4. This Ordinance shall take effect and be in force from and after its passage, approval, and publication as may be required by law.

Section 5. If any part of this Ordinance shall be deemed to be invalid, the remaining parts shall remain in full force and effect.


