#### Highway Commissioner's Report (written statement)

The Highway Department is currently completing the final round of right-of-way mowing for the year. Both the Cheshire and Lakeview Drive road construction projects have been completed. One easement has been obtained to complete repairs on the Villa Drive bridge. A street resurfacing projects on Cloverleaf Road has been completed. The Highway Department delivered all the election equipment to polling places within Stookey Township. All snow removal equipment is being tested for use in the coming winter months. Road salt has also been purchased. Commissioner Reed then wished all residents a happy Thanksgiving.

#### **Supervisor's Report**

Ogles Neighborhood Watch named Stookey Township Board of Trustees as their October Great Neighbor recipient. New cured sewer piping is now being laid in the Country Club Acres neighborhood. A new fence has been installed at the sewer plant. Supervisor Bagby then reminded Stookey residents of the Tuesday, November 5<sup>th</sup> general election.

#### **Discussion of Tax Levies**

Ordinance 2024-09 was discussed by the Board of Trustees. The Town will levy in the amount of \$579,964.04. The amount is 3.34% higher than the previous year. The proposed Levy will be available for public viewing for a period of 20 days and voted upon at the December regular board meeting.

### **Discussion and Approval of Streetlight Requests**

Citizens in the Country Club Neighborhood had recently requested additional lighting. The Lighting & Zoning Committee approved the addition of four streetlights. The Old Lantern Neighborhood also requested additional lighting. The Lighting & Zoning Committee stated there was currently sufficient lighting in the neighborhood.
